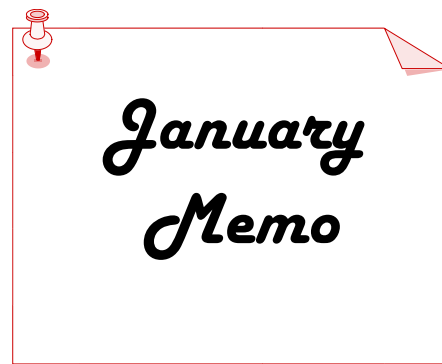

Important Information for Child Care Providers

In the last two weeks we have become aware of a scam which is targeting child care providers in our community. Providers have been approached by an individual attempting to fraudulently obtain funds through a scam called "Cheque Overpayment Fraud" where a potential client will advise a child care provider they wish to secure a child care space and will forward a cheque greater than the amount required to secure their space. They will then contact the child care provider asking them to forward them a cheque for the overpaid amount.



Caregivers should never agree to a transaction in which a potential client wishes to issue a cheque in an amount greater than the contract requires. 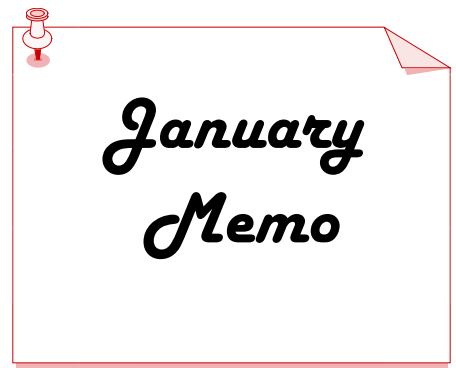
