

Child Care – the Liberal Party's platform

With this newly elected Prime Minister and a Liberal majority, the question of Child Care will again be brought forward and we will all be watching to see what the new government will do in this area.

The Liberal Party's platform pre-election stated that they would meet with Provinces, Territories and Indigenous Communities to begin work on a new National Early Learning and Child Care Framework. They realize that the child care needs vary from family to family and each Province and Territory have proven that there is not a one-size fits all National Program that would work for all. The Liberal party stated that having a plan that imposed a pre-determined cost on other orders of Government would be impractical and unfair.

We will need to wait and see if the framework they design will be administered in collaboration with Provincial jurisdictions and suit the needs of each Province.

Funding available for schools and daycares to create outdoor classrooms and play areas

The <u>Toyota Evergreen Learning Grounds program</u> helps schools create outdoor classrooms to provide students with a healthy place to play, learn and develop a genuine respect for nature. Since the program began in 2000, it has provided funds to over 3,000 schools from coast to coast, providing countless opportunities for students to engage with nature on their school grounds. Up to \$3,500 for public schools and daycares located on school Board/District property and applications for the 2015–2016 funding cycle will be accepted on 3 intake dates throughout the school year:

- Monday, September 28, 2015
- Monday, December 14, 2015
- Monday, March 28, 2016

Baby Food Jar Snow Globes

www.craftaholicsanonymous.net/

Supplies:

Distilled water

Empty baby food jars Mini fake trees Goo Gone Glycerin {I found it at the Walmart pharmacy} Glass & Bead glue OR Epoxy Glitter {colored chunkier glitter works best. Don't use clear or fine glitter} Gold spray paint

Remove the labels off the jars and clean off the glue with Goo Gone.

Spray paint the lids gold (or desired color). Put a little glue on both the inside of the lid and the bottom of the fake tree. Allow to dry for 1-2 minutes and then press the tree onto the lid. Allow to dry for 24 hours. 4.

Add about 1 teaspoon of glitter into each jar.

Fill with distilled water and add 5 drops of Glycerin. {5 drops seemed to work the best.} Screw the lid {with the tree} onto the top and you've got yourself the cutest mini snow globe ever!

CAN CHILD CARE FEES GET ANY HIGHER? REPORT SHOWS CHILD CARE FEES ACROSS CANADA ARE STILL RISING AND UNAFFORDABLE FOR CANADIAN FAMILIES

DECEMBER 10, 2015

OTTAWA — The Canadian Centre for Policy Alternatives (CCPA) new report, 2015 Child Care Fees in Canadian Cities reveals that child care fees for most Canadian families continue to rise, vary dramatically across the country and are very expensive in some cities. The only effective way of lowering and managing these unaffordable fees is to provide direct operational support to child care programs. Further, the report provides support for national leadership and planning that supports a national child care system for Canadian families.

"The financial pressure from sky-high child care fees is a tremendous stress for many Canadian families," said Don Giesbrecht, Canadian Child Care Federation CEO. "This report adds further evidence that Canada needs a national child care plan and one that supports families through affordable fees as well as high quality services from which to choose. It is time for governments across Canada to come together and work collectively for the benefits of Canada's children and families."

This new report, supported by the Canadian Union of Postal Workers (CUPW) recaps that of the previous year's report with the addition of five more cities and a review of low income subsidy systems in each city. It surveys fees for three age categories of child care (infants, toddlers, and preschoolers) in 27 Canadian cities, and the different subsidization regimes that reduce fees for low-income families.

"In the highest fee city of Toronto, it is normal for a couple with two children under five to pay \$28,300 in annual child care fees," the report states. "That is the equivalent of 48% of the median family after-tax income in that city, but high costs are just part of the challenge. Even where families can afford to pay this much for child care they will often face long waiting lists due to significant shortfalls in available regulated spaces.

The report concludes, "Canada's child care systems can vary dramatically from province to province and city to city, but two things hold true in nearly all places: child care is expensive and regulated spaces are hard to find.."

12 Tips For Holiday Home Safety

- 1. Merry and Bright: Carefully inspect holiday light strings each year and discard any with frayed cords, cracked lamp holders, or loose connections. When replacing bulbs, unplug the light string and be sure to match voltage and wattage to the original bulb.
- 2. Lights Out: Always turn off holiday lights when you leave the house unattended or when going to bed.
- 3. Fresh Is Best: Try to purchase a freshly cut tree, as they are more resistant to ignition. Keep your <u>Christmas</u> tree watered and away from open candles.
- 4. **Timing Is Everything:** Use an outdoor timer certified by CSA International to switch lights on and off. Lights should be turned on after 7 p.m. to avoid the electricity rush hour.
- 5. **Check for the Certification Mark:** When purchasing light strings, extension cords, spotlights, electrical decorations, gas appliances, or carbon monoxide alarms, look for the certification mark of an accredited certification organization such as CSA International, UL, or ELT to ensure that the products comply with applicable standards for safety and performance.
- 6. One and Done: Never connect more than one extension cord together; instead use a single cord that is long enough to reach the outlet without stretching, but not so long that it can get easily tangled.
- 7. **The Great Outdoors:** When hanging outdoor lights, keep electrical connectors off the ground and away from metal rain gutters. Use insulated tape or plastic clips instead of metal nails or tacks to hold them in place.
- 8. **Climbing Up:** Using a ladder when you put up lights? Choose the correct ladder for the job and double check for a certification mark to ensure your portable ladder complies with applicable standards.
- 9. **Keep the Gas Behind Glass:** Do not use your gas fireplace if the glass panel is removed, cracked, or broken, and only allow a qualified service person to replace fireplace parts.
- 10. **Sound the Alarm:** Test your smoke alarms monthly to make sure they work, and be sure to install smoke and carbon monoxide (CO) alarms on every level of your home -- especially near sleeping areas.
- 11. Filter-Friendly Furnace: To help prevent CO hazards in your home, have a qualified heating contractor perform a yearly maintenance check of your furnace and venting system, and clean or replace your furnace filter frequently during the heating seasons.
- 12. Clean the Clutter: Do not store combustible materials such as gasoline, propane, paper, chemicals, paint, rags, and cleaning products near your gas furnace. Gasoline or propane cylinders should be stored outside the home.
