## Cleaning Supplies

MCFD has distributed a shipment of 20 1-litre bottles of hand sanitizer to open facilities with 100 or more licensed spaces. As this sanitizer is an alcohol-based liquid, it can also be used for cleaning surfaces. These centres are encouraged to share these resources with other providers in their community, if they are able. Review the list of the [providers that received hand sanitizer](#). We will continue to work on supporting child care providers to gain access to additional cleaning supplies.

## Information Updates

As of April 28, 88% of active child care facilities have signed up for [Temporary Emergency Funding](#) (TEF). Of those signed up, 62% remain open and together offer a total of 59,749 child care spaces for families who need care across the province.

There have been modifications to the list of daily essential service workers identified within the healthcare sector. It includes those who provide health care and services, including mental health and addictions treatment. A [complete list of these positions](#) are now available.

The B.C. government has also established an [Emergency Relief Support Fund](#) for children and youth with special needs and their families. The fund will provide a direct payment of \$225 per month to eligible families over the next three months (to June 30, 2020). This funding is in addition to more flexible policy guidelines for Children and Youth with Special needs (CYSN) services.
